Dear Comrade,

With deep regret I am informing you that an incident of manhandling was happened with our member, **Branch Manager Hallia Branch on 20.11.2019**. The matter was came to our knowledge on 22.01.2019 Friday, through other member of a nearby Branch which was immediately taken up with RM of the region. DGM(B&O) Varanasi and GM Network 3 was not available on that day due to Town Hall meeting. Hallia is last Branch on UP-MP Border in Mirzapur District under RBO-2 Varanasi Module. **Our Chief Regional Secretary Shri Suresh Chand had offered Regional Manager to accompany with him for delegation to District Authorities for early arrest of culprits** but management had opted another route and canvassed Deputy Inspector General of Police of Vindhyachal range through Chief Manager, Mirzapur Branch who was assured for an immediate and satisfactory action. But culprits had acquired Bail from Local Police Station. So, considering no development at all fronts, we, undersigned, Circle President Com Ajay Saxena alongwith CRS Com Suresh Chand and Regional President Com Rajesh Mali visited Mirzapur on 26.11.2019 after Holidays of Saturday and Sunday to met Senior Administrators of Mirzapur Distt with an objective to boost the morale of our members after the disheartening incidence of manhandling.

In addition to members, we met with Superintendent of Police and Deputy Inspector General of Police, the top most Cops of District and Region and submitted a memorandum giving emphasis on early arrest of Culprit for restoration of our confidence in Banker's Security. **Superintendent of Police and Deputy Inspector General of Police has instructed to Incharge Police Station Hallia for immediate arrest of Culprits. Superintendent of Police Mirzapur has also assured to provide police security to all Bankers whenever required.**

Deputy Inspector General of Police Vindhyachal Range during discussion had acknowledged dedication of Bankers towards Society.
